## **TERMS & CONDITIONS**

1. Artist(s)/vendor(s) agree to comply with **ALL** the guidelines set forth by Promoter. The artist(s)/vendor(s) understand that removal from the event is at the discretion of the event organizers and ALL deposits and/or payments will be forfeited. ALL booth fees are non-refundable.
2. Artist(s)/vendor(s) must display appropriate conduct at ALL times. Music is to be kept at a normal sound level as it conflicts with the announcements. The show will provide music throughout the show. One warning will be given for LOUD music prior to being told NO music at the booth.
3. Each booth is described as pipe and draped area (10x10) with tables, chairs, trash receptacle, and electric hook-up. Any additional material provided to the artist(s)/vendor(s) is at the discretion of the Promoter. **NO OUTSIDE tables are permitted. Additional tables are available at an additional fee (\$10 each) purchased at check-in. Clothing racks and display cubes/shelving are acceptable.**
4. An artist(s)/vendor(s) booth is described as a pipe and draped area, approximately 10 x 10 with two (2) draped tables, four (4) chairs, one (1) trashcan, and an electric hook-up. Each booth is intended for the use of two (2) tattoo artists + one (1) helper, or two (2) merchandise agents and will receive badges/armbands. **Additional arm bands are available at an additional fee (\$15 each) limit of 1 per booth and purchased at check-in.**
5. The artist(s)/vendor(s) agree **NOT** to alter the booth size assigned to him/her/them. Damages to the property of the hosting hotel caused by themselves, their agents, employees, guests, and/or clients will be reimbursed to the hotel and Promoter.
6. **The** checklist of the booth will be verified at check-in to ensure the booth agreement is correct by the artist(s)/vendor(s) and Promoter.
7. The artist(s)/vendor(s) agree to maintain a clean booth area which includes proper bagging of trash each day for removal and ensuring the area is contained before departing at the end of the day/show.
8. The artist(s), if tattooing, agree to use single-use needles and inks, use of certified sharps containers to dispose of used needles, following recognized professional tattooing standards, and maintain a clean/safe workspace.

9. Reminder that the sale of tattoo machines and/or equipment and supplies to the general public is forbidden at this event, and is a violation of this contract.

10. Soliciting customers outside of any given booth area is strictly prohibited and is a violation of this contract.

11. Artist(s)/Piercer(s) agree to verify age of client and a signed release prior to services rendered. Min age for service is 18 for tattoo services.

12. **Deposit** is due with application and signed contract and **FINAL PAYMENT DUE** by **SEPTEMBER 1, 2024**. Booths **NOT** paid in **FULL** by this date are subject to being resold and **ALL monies forfeited**.

13. **NO smoking/vaping permitted** in the show area designated areas outside will be posted.

14. This contract may **NOT** be altered except by amending the agreement in writing and executed by each of the parties. Each obligation of this contract, even though not expressed as a covenant, is considered for all purposes to be a covenant.

15. **By signing this contract you and all persons at the booth agree to the terms stated above.**
